


Prof. (Dr.) A. Kumarswamy

Hence, she takes up the post of Resource person and the coordinator of Post graduate Certificate course in Aesthetic Dentistry conducted at MCODS, Manipal.

A compassionate clinician received the "Best Clinician Award" by the Karnataka State Academy of Conservative Dentistry and Endodontics in 2019 speaks her skills. Oro-facial clefts are among the most common congenital anomalies requiring multidisciplinary care. Such anomalies include several handicaps such as impaired suckling, defective speech, deafness, malocclusion, gross facial deformity and severe psychological problems. Cleft lip and palate is one such condition that requires a multidisciplinary approach for its management.

This presentation deals with step by step systematic representation of Comprehensive Surgical, Orthodontic and Prosthodontic rehabilitation of unilateral as well as bilateral cleft lip & cleft palate patients by show casing multiple treated cases. This presentation gives bird's eye view of presurgical infant orthopedics between 0-3 months, primary lip repair between 3-6 months, palatoplasty between 18-12 months followed by speech therapy between 6-12 years.

Early orthodontics started by the age of 7-8 years with the help of PAE appliance along with slow maxillary expansion with the help of quad helix. After correction of crossbite, the patients were referred to oral surgeon for Alveolar bone grafting between the age of 9-11 years followed by prosthetic rehabilitation at the end of Orthodontic treatment along with Orthognathic surgery between 17-19 years.

Thus, orthodontist, maxillofacial surgeon and prosthodontist work together to provide a customize and comprehensive treatment plan to create a winning combination that eliminates or minimizes the physical, social and emotional hardship and brings out the best in the patient with a single minded approach.


